The Federal Trade Commission (FTC) pledges not to drop any numbers from Do Not Call Registry, so there is no longer a need to renew your status. ## Frequently asked CPNI questions

*(Account Passwords)*

**Are there other ways to release call detail information if you forget your password or choose not to set one up?** Yes. There are three other ways to release call detail information. 1) WTCI could call you back at the number on record. 2) We could mail or email the CPNI information to the address on record. 3) You, the authorized account customer, could come into the office and show a valid photo ID.

**Can my spouse/roommate/child get CPNI information from our account?** Only if he/she is listed on the account. Even if your spouse knows the password, WTCI cannot share CPNI information with them unless they are listed on your WTCI account. Please add your spouse or anyone that may need access to your account information. If someone else is paying your bill or you rely on them to make account changes, it is very important to have that person added to the account as well.
